### **COUNCIL MINUTES**

December 8, 2021 at 8:15 PM

Meeting was called to order by Dean Nelson and opened with prayer.

#### **Audit Review:**

The audit team (Wally Stommes, Jeff Legge & Gwenda Buttke) presented a summary of the audit:

- Purpose of the audit was to:
  - 1. Confirm the accuracy of financial information
  - 2. Perform a check on the church's financial processes
  - 3. Determine best practices that help assure financial integrity.
- The church's last audit was performed 18 years ago and the Council agrees this should be done more frequently.
- Summary of Findings:

The audit team found Val and Kaitlin to be cooperative in the audit effort and very competent and conscientious in carrying out their roles. The church finances in general are accurately and conservatively recorded. Most recommendations by the audit team are improvements on already well -run processes. The new accounting system cost effectively maintains both financial security and accounting functionality. It should also be noted that Val Lundby took the initiative to investigate and generate nearly \$2600 in sales tax refunds during 2020.

 The audit team made recommendations for improvements, which the Council decided to further discuss in future meetings.
